Sub :Intimation pursuant to Regulation 30 of SEBI (Listing Obligation & Disclosure Requirements) Regulations, 2015 in respect of implementation of the scheme of arrangement.

Kindly refer our intimation on 18th July, 2020 pursuant to Regulation 30 of SEBI (Listing Obligation and Disclosure Requirements) Regulation, 2015 (LODR) in respect of taking note of the order of Hon'ble NCLT dated 06/07/2020 vide its order no. CP (CAA)/190/MB.I/2017, approving the scheme of arrangement between Kumaka Industries Limited and its Equity Shareholders following major points of order passed by Hon'ble NCLT dated 06/07/2020,

1. Ratification of reduction of 18,09,750 shares by conversion of 24,13,000 partly paid up shares to 6,03,250 fully paid up shares.
2. Reduction of share capital by cancellation and extinguishment of 10375 fully paid up shares allotted to 406 shareholders and transfer of fully paid up 10375 by the promoters at the rate of 0.005 paisa per share.
3. Restore the rights of the said 406 shareholders, rearranging and numbering the distinctive numbers of shares to reconcile the same with the paid-up share capital.
4. Issue and allotment of 21,04,865 fully paid up shares as bonus shares to the public shareholders of the company out of the free reserves of the Company.

In the regard, we would like to clarify pursuant to regulation 30 of LODR that by virtue of taking note of above, point no.1 to 3 stand implemented and accordingly the paid up capital of the Company stands reduced to 1,20,75,250 equity shares of Rs. 10/- each. 
